General Description of Position

The Director of the Church Ambassador Network is a relationship maker. They work to fulfill the overall mission of The Florida Family Policy Council, and to inspire the Church to engage government for the advancement of God's kingdom. They are the facilitator between the shepherds of God's Church and the shepherds of God's government. Coordinating with the elections and policy team, they work to build relationships that will not only help government carry out justice but will also further the Gospel throughout the halls of government. It is essential the director has or will be committed to developing strong relationships with both pastors and elected officials that are centered around the Great Commission.

Ability to work discreetly with high level of integrity, honesty, and confidentiality. Trustworthy and responsible. Tactful and diplomatic, building consensus rather than emphasizing differences. High level of professionalism. Strong leadership qualities. Knowledge of the Bible and or Christian theology. Professional appearance.

Location

Idea candidate must be located in Tallahassee, Florida or willing to relocate to the Capitol City. For an exceptionally qualified candidate, commuting during session from a city other than Tallahassee is a possibility.

Summary of Responsibilities and Objectives

Director of Ambassador Network Responsibilities

- **Pastor/Church Outreach**
 - Maintains and builds statewide relationships with pastors
 - Builds a pastors' steering committee made up of influential local pastors and denomination leaders.
 - Builds intentional relationships with government leaders, lobbyists, and staff
 - Connects pastors with government leaders, lobbyists, and staff.

- Leads the Capitol Project by bringing pastors to the Capitol during the legislative session to build relationships with their elected officials
- Models and leads in witnessing the Gospel to all
- Looks for avenues to work with both sides of the aisle
- Uses policy to advance the Gospel and reflect God's standard of justice and righteousness
- Educates and advocates for a biblical relationship between Church and State
- Further develop and maintain a proprietary database of pastor/church contact info from across the state of Florida in conjunction with the CRM and list coordinator
- Provides tools for churches to use that educate the congregation on God's institution of government and why it is biblically important to vote and engage government at all levels
- Provide resources to pastors including policy resources, speakers, and bulletin inserts
- Keeps pastors regularly informed in the work of the mission
- **Development**
 - Travel and share with churches the mission and vision of the CAN
 - Encourage churches to include FFPC in their missions' budget
 - Solicit donors who wish to advance the mission of the CAN
 - Work toward making the CAN wholly church supported
- **Events and Promotion**
 - Plan ahead for major events such as elections, legislative sessions, court cases, or other times when the timeless voice of the church will need to be spread in our culture
 - Schedule events as needed in conjunction with FFPC event staff
 - Coach each team member within the organization on how to represent CAN at events or in personal conversation
 - Maintain updated digital and printed materials for the support and marketing of the mission of the CAN in conjunction with the media coordinator

Ambassador Network Objectives

To support the FFPC mission through partnerships with pastors and churches across the state of Iowa. The first objective being encouraging pastors to build intentional relationships with governing leaders with a goal of sharing the Gospel, making disciples, and promoting justice and righteousness in their personal and public lives. The second encouraging pastors to equip their congregation with biblical truths on government and societal issues of the day.

Reporting & Measurables

The Director of the Church Ambassador Network shall be prepared report to the president on the number of churches and pastors engaged with FFPC across the state of Iowa. And shall report specifically on the involvement of pastors in the civic and legislative process as measured by visits to governing leaders. The Director shall also track the giving of churches to the CAN with a goal of full support from participating churches.

Schedule & Availability

The Executive Director of the Church Ambassador Network is a full-time position with normal working hours of 9 a.m. to-5 p.m. Monday-Friday with occasional travel required on other days and times for events or outreach.

Ability to work discreetly with confidential data. High level of integrity, honesty, and confidentiality. Trustworthy and responsible. Tactful and diplomatic, building consensus rather than emphasizing differences. High level of professionalism. Strong leadership qualities. Professional appearance.
